Presenter: Interim Chief Louie Bright, III, Dallas Fire-Rescue Department

Action Taken/Committee Recommendation(s):

The purpose of the briefing is to provide an overview of the Dallas Fire-Rescue Department to include its History and Current Operations. 5. City of Dallas Emergency Management Overview

Presenter: Kenny Shaw, Managing Director, Office of Emergency Management

Action Taken/Committee Recommendation(s):

The purpose of the briefing is to provide an overview of the City of Dallas Emergency Management Department to highlight the following topics: (1) Role and responsibilities (2) Plans for major incidents and events (3) Funding (4) Facilities, Equipment and Technology (5) Partners and (6) Programs. The goal of Emergency Management is to ensure that the City if prepared to protect its citizens and to recover from the effects of an emergency or disaster. The Department does this by:

- Producing emergency plans
- Providing for appropriate technology
- Developing partnerships with hospitals, non-profits, businesses, and volunteers
- Developing regional relationships to assure a large scale capability

Presentation highlights were as follows: (1) City Code – Chapter 14B (2) history of Emergency Management (3) Four Phases of Emergency Management (4) OEM Organization and Staffing and (5) Key Programs and Projects.

In summary, the central mission is to keep the community ready to respond to a catastrophic event. The department's key responsibilities are as follows:

- Keeping emergency plans updated
- Maintaining the EOC and its technology
- Working with medical, businesses, non-profits, and volunteers to assure safety and preparedness
- Working with the State and FEMA to assure readiness and funding
