# Purpose

# Background – Shelter Construction

- November 15, 2001 – Animal Shelter Commission recommends construction of new shelter facility
- May 3, 2003 – Bond Proposition 7 is approved by Dallas voters for the design and construction of a new shelter
- October 20, 2007 – Dallas Animal Services and Adoption Center opened on Westmoreland at I-30
  - Total cost \$16.2M and included:
    - \$3.5M from the 1998 Bond Program
    - \$11.7M from the 2003 Bond Program
    - \$1.0M from the Ivor O'Connor Morgan Trust

# Background – Ordinance Updates

- 2007 - Commission recommends a review of the Chapter 7 Animal Ordinances
- Council approved the new ordinances that focus on pet owner responsibility in June 2008
  - Limits pets to 6 per household
  - Establishes guidelines for anti-tethering
  - Establishes spay/neuter and intact animal requirements
  - Strengthens rules for dangerous dogs

# Background – HSUS study

- In October 2009, the Animal Shelter Commission recommended a follow-up to the 2001 review of Animal Services division by the Humane Society of the United States (HSUS)
  - Metroplex Animal Coalition donated \$25,000 to fund the review
- HSUS review was initiated in April 2010 and final report was received November 2010
  - Status is provided in this briefing
- In August 2011, the City Council approved discounted adoption fees

---

# Overview of Animal Services

- Animal Services is a division of Code Compliance and is budgeted for 81.5 FTE's and \$6.3M for FY11-12
- Shelter Operations
  - Operates a sheltering division that cares for and houses over 800 animals daily, approximately 34,000 annually
  - Provides in-house medical care & neutering surgeries to pets released from shelter
  - Provides lost & found services to reunite owners that have become separated from their pets.
  - Provides pet adoptions and rescues

# Overview of Animal Services

## ■ Field Operations

- Provides for care and control of animals in the City through enforcement of Chapter 7 of the Dallas City Code and Texas Rabies Control Act
- Dallas responds to more than 50,000 service calls annually for animals on a 24/7 basis
  - Average 145 calls every day in FY10-11
  - 73% of the total calls are for loose, confined and sick/injured animals

# Shelter Manager – Jody Jones

- Appointed Division Manager for Dallas Animal Services in June 2011
  - Began work in animal services as a volunteer at a small rescue operation
  - Over fourteen years experience in animal services, including: Division Manager for the City of Richmond, Virginia Animal Care and Control and shelter manager with NYC Animal Care & Control
  - Implemented a program to eliminate homeless pet euthanasia while at Richmond
  - Board member of the Virginia Federation of Humane Societies
  - Faculty member of the American Prosecuting Attorneys Association for the Committee on Animal Law

# HSUS Evaluation Update

- The HSUS evaluation report was provided to City Council by memorandum on November 29, 2010
- Key findings in the report included:
  - The need for additional written standard operating procedures;
    - Policy revision has been initiated and is an ongoing procedure for the division
  - The need to clarify the mission and vision of DAS and align the Commission's goal with that of the City of Dallas
    - The mission statement was completed in April 2011 with input from staff, community and the Animal Commission
  - Recommendations for improvements in the use of equipment and maintenance of the shelter facility.
    - Equipment training and maintenance procedures and policies have been updated to reflect appropriate use and care of equipment.

# HSUS Evaluation Today

- Improvements have been prioritized, and based on priority all planned improvements are on schedule
- A full update on the implementation of recommended improvements will be provided to the Animal Shelter Commission in March 2012 and to the Quality of Life Committee in April 2012

---

# New Initiatives

- Implemented team building committees and activities to improve staff morale and training
- Facilitating ongoing building upgrades & repairs
- PetSmart Charities Grant awarded Dallas Animal Advocates to facilitate enhanced data collection at DAS
- Standardized community reporting using national model
- New Lost & Found website ([www.petharbor.com](http://www.petharbor.com)) went live in November 2011 to reunite more lost pets and families

---

# New Initiatives

- Implemented new animal identification system
- Expanded division neutering services through partnerships and vendor contracts
- Began vaccinations and exams on intake to promote health
- Revised animal care assignments to maximize animal health and placements
- Initiated public service announcement campaign in order to encourage adoptions from DAS
- Dallas Companion Project forming plan to engage the community to reduce euthanasia of healthy adoptable animals

# New Initiatives

## ■ Discount Adoption Rate Results

- ❑ 438 adoptions for the month compared to 249 in December 2010
- ❑ December Tues, Wed, and Thurs special rate more than doubled adoptions for same days in 2010

## ■ Clients Served Increased

- ❑ October – 5,920
- ❑ November – 4,467
- ❑ December – 10,644 (special adoption rates)
