3. <u>Dallas Fire-Rescue Dual Career Paths</u>

Presenter: Captain George Florence, Dallas Fire-Rescue Department

Action Taken/Committee Recommendation(s):

The purpose of the briefing is to describe the two careers paths within Dallas Fire-Rescue which are as follows: (1) Fire & Rescue Officer and (2) Fire Prevention Officer. Captain Florence provided the committee with an overview of the two career paths:

• Fire & Rescue Officers are trained to respond to medical emergencies, fires, vehicle collisions, Haz-mat incidents, and to mitigate life safety hazards.

Minimum Qualifications:

- Minimum 18 years old
- 45 Semester hours of college/ or 4 years active duty military service, with a honorable discharge
- No more than 3 moving traffic violations within 24 of months applying
- No pending civil or criminal cases during the application process
- Must be legally eligible to work in the United States

Training Requirements:

- 28 Week Fire Academy consisting of the following: (1) 468 hours for TCFP curriculum & skills and (2) 500 hours DFR curriculum & skills
- 5 Weeks Emergency Medical Technician
- 5 Months Paramedic School
- 6 Months probationary period
- **Fire Prevention Officers** perform technical inspections of all public buildings, schools, high-rise buildings, monitor crowd capacity at public events, conduct educational programs at schools, nursing homes, and public events.

Minimum Qualifications:

- Minimum 19 years old
- 60 Semester hours of college/ or 5 years active duty military service, with a honorable discharge
- No more than 3 moving traffic violations within 24 of months applying
- No pending civil or criminal cases during the application process
- Must be legally eligible to work in the United States

Training Requirements:

- 196 hours for TCFP curriculum & skills
- 160 hours City of Dallas Fire Code
- 160 hours On-the-Job Training
- 6 Months probationary period

The committee had the following concerns/recommendations: (1) Future presentation on the pro's/con's of combining career paths (ex. budgetary impact single vs. dual & efficiencies) (2) Difference in college hours for Fire & Rescue Officer vs. Fire Prevention Officer (3) Demographic results (4) How does Dallas compare with number of female firefighters w/Index cities (5) What steps or measures has the department taken to reach the single career path and (6) Recommend cross training.

4. Dallas Fire-Rescue Wildland Strike Team Deployment

Presenter: Lt. Sam Friar, Dallas Fire-Rescue Department

Action Taken/Committee Recommendation(s):

The purpose of the briefing is to explain the involvement of the Dallas Fire-Rescue Wildland Firefighting Team in support of uncontrolled wildfires around the State between September 1st and September 17th 2011. The objectives of the Wildland Strike Team are as follows:

- Deploy quickly
- Integrate into a unified command structure consisting of national, state, and numerous local agencies
- Provide Wildland Firefighting support through the Texas Intrastate Fire Mutual Aid System (TIFMAS) to communities throughout the state

The committee had the following concerns/recommendations: (1) Total number of acres covered (2) Weather related fires and (3) 78 person Wildland Firefighting Team.

5. <u>Dallas Fire-Rescue Fire Investigation & Explosive Ordnance Disposal</u>

Presenter: Deputy Chief Joe Pierce, Dallas Fire-Rescue Department

Action Taken/Committee Recommendation(s):

The purpose of the briefing is to provide an overview of the Fire Investigation and Explosive Ordnance Disposal (EOD) Division. The goals of the Division are as follows: (1) Improve citizens level of safety by reducing the incidence of arson fires in the City of Dallas through enforcement, awareness and intervention and (2) Lower the crime rate.

The primary duties of Fire Investigators are:

- Determine the origin and causes of fires
- Collect evidence
- File criminal charges when appropriate
- Arrest and process suspects
- Testify in criminal proceedings

The committee had the following concerns/recommendations: (1) Vehicle arson (2) 2006-2011 Arson Incidents & Arrests and (3) What is in place to share information for Public Awareness.
