## 4. 2012 Dallas Police Department Traffic Contact Data Annual Report

The purpose of this presentation is to provide a comprehensive 2012 Traffic Contact Data Annual Report for the City of Dallas and give an overview of statistical citizen contacts made by police.

Goals of the report are as follows:

- Conducting a yearly analysis of Departmental statistical data helps to increase citizen confidence by:
  - Showing that the Department is in compliance with applicable Texas law on the collection of racial profiling data
  - Providing recommendations as needed to ensure our department continues to follow state guidelines regarding racial profiling
