3. FY 08-09 Public Safety Key Focus Area Preliminary Ranking of Bids

Presenter(s): Deputy Chief Jan Easterling, DPD

Dave Cook, Chief Financial Officer, DPD

Action Taken/Committee Recommendation(s):

Mr. Cook gave an introduction to the FY 08-09 Public Safety Key Focus Area Preliminary Ranking of Bids. The purpose of the briefing is to review price of government process, review status of budgeting for outcomes process, review Public Safety Preliminary List of Offers/Services to be "Purchased" in FY 2008-09 and review next steps in Price of Government Process.

Public Safety Envisioned Future; Enhance Public Safety to ensure people feel safe and secure where they live, work and play.

Public Safety Council Objectives; (1) improve response times (2) reduce the overall reported crime rate (3) increase the level of confidence in law enforcement and (4) reduce the Dallas' position in the nation on crime.

The committee had the following concerns/recommendations: (1) public safety funding (2) Fire-Rescue enhancements (3) Advance Life Support engines (4) officer vacancy rate (5) beat patrol (6) overtime comparison for last year vs. this year's proposal (7) uniform pay plan (8) team recommends not funding this bid (9) back-up dispatch and call center (10) CAD (11) additional security guard outside the communication center (12) administrative assistant for the arson team and (13) security for Mayor and Council offices and chambers.

4. Crime Report

Presenter(s): Police Chief David M. Kunkle, DPD

Action Taken/Committee Recommendation(s):

Chief Kunkle provided the committee with an overview in percentages. One of the key focus areas is public safety and one of the most important goals if to reduce crime. The highest single goal is how the department is doing as it relates to crime. The following is a summary of the current crime report: (1) 9% down in violent crime (2) 2% up in crimes against property (3) overall crime reduction citywide down 10% (4) Northeast Patrol Division had an 8% increase (5) Northwest Patrol Division had a 6% increase and (6) Central Patrol Division has the greatest decrease in crime.

The committee had the following concerns/recommendations: (1) youth initiative curfew (2) reduction in response time (3) improve strategies in residential burglaries (4) VIP (5) violent crime stats for U.S. (6) multi tenant tactics and (7) Sky towers.

Follow up: The committee requested a future briefing on the following topic: (1) summer imitative.

5. Homicide Report

Presenter(s): Lt. Craig Miller, DPD

Action Taken/Committee Recommendation(s):

Chief Kunkle provided the committee with some important demographic information about homicides: (1) most violent times of the day are 10:00 p.m. to 2:00 a.m. (2) most dangerous days of the week are late Friday night and early Saturday morning (3) every year about 90% of murder victims are African Americans and Hispanics and (4) 75% of the murder victims are killed with handguns. Lt. Miller gave an overview of the motives in homicide.

The committee had the following concerns/recommendations: (1) handguns (2) gun shows (3) hot spots (4) Sky towers and (5) additional cameras.

6. DWI No-Refusal Initiative

Presenter(s): Deputy Chief Nancy Kirkpatrick, DPD

Action Taken/Committee Recommendation(s):

Deputy Chief Kirkpatrick provided the committee with the DWI No-Refusal Initiative. Topics of the presentation were as follows: (1) search warrant for blood sample (2) procedure (3) Memorial Day initiative and (4) July 4th initiative.

The committee had the following concerns/recommendations: (1) judge commitment (2) fine for breath test refusal (3) citizen rights (4) Attorney General opinion and (5) administrative fee for the breath test.

Follow up: The committee requested staff to provide a follow up to the Memorial Day Initiative.

A motion was made by Mr. Natinsky to move forward with the DWI No-Refusal Initiative, including the recommendation for restitution and that this item return to the Public Safety Committee, so the committee can reevaluate the success and then move forward to full time implementation. Mr. Caraway seconded the motion and it passed by unanimous vote.
