3. Crime Report

Presenter(s): Police Chief David M. Kunkle, Dallas Police Department

Action Taken/Committee Recommendation(s):

Chief Kunkle provided the committee with a discussion of the crime briefing. One of the key focus areas is public safety and one of the most important goals is to reduce crime. The following is a summary of the current crime report: (1) crime numbers continue to trend downward and (2) homicides are down 5%.

The committee had the following concerns/recommendations: (1) hiring additional officers (2) mandatory four officer response on service calls (3) hot spots (4) mandatory crime reduction program and (5) multi family crime list.

4. Police Vehicle Operations Course (PVOC) Overview

Presenter(s): Lt. Vernon Hale, Dallas Police Department

Action Taken/Committee Recommendation(s):

Lt. Hale provided the committee with a discussion of the Police Vehicle Operations Course (PVOC) Overview. The training was created in 1989 in order to enhance driving skills to save lives, reduce injuries and reduce damage to vehicles and property.

The committee had the following concerns/recommendations: (1) status of suspects (2) teen driving and (3) plans to review pursuit policy.

Presenter(s): Lt. Todd Thomasson, Dallas Police Department

Action Taken/Committee Recommendation(s):

Lt. Thomasson provided the committee with a discussion of the Dallas Police Department (Fusion Center). Highlights of discussion were as follows: (1) philosophy (2) database access and process (3) daily operations (4) high profile criminal investigations (5) fusion network capabilities (6) urban area security initiative funding and (7) privacy policy.
