3. Crime Report

Presenter: Chief of Police David Brown, Dallas Police Department

Action Taken/Committee Recommendation(s):

Chief Brown provided the committee with a progress report of the Police Department in crime. Violent crime has decreased 10% and all categories are in the negative. Murder category has decreased to 4.9%. Aggravated assault has decreased to 5.9%. Property crime counts for 88% of crime in Dallas, predominate during the daytime hours. The large majority of total crime in Dallas is non violent. Burglary and theft are the major categories of property crime. Residential burglary has decreased to 16%, business burglary decreased to 12% and burglary motor vehicle has decreased to 18%. The priority of the Police Department is crime prevention.

The committee had the following concerns/recommendations: (1) 2 week officer rotation in patrol (2) enhancement training (3) increased officer visibility in urban neighborhoods (4) requirement for uniform officer at auto pound (5) number of sworn working in civilian jobs (6) which positions can be civilianized (7) Crime Watch and (8) strategies in crime prevention, balancing resources and targeting crime during specific times.

4. Love Field Police Unit

Presenter: Deputy Chief Brian Harvey, Dallas Police Department

Action Taken/Committee Recommendation(s):

Deputy Chief Harvey provided the committee with the Love Field Police Unit. The mission of the Love Field Police Unit is to provide and portray a safe environment for travelers, patrons, and employees at Dallas Love Field Airport through honesty, fairness, professionalism and respect for human life and personal dignity.

The committee had the following concerns/recommendations: (1) fire apparatus on field (2) number of shifts and (3) emergency evaluation plan for Love Field.

5. Legislative Agenda Results (Informational Memo)

Presenter: Lieutenant Gary Tittle, Dallas Police Department

Action Taken/Committee Recommendation(s):

Lt. Tittle provided the committee with the Legislative Agenda Results. During the fall of 2010, the City of Dallas legislative agenda was created. Information included was the results of bills related to the Dallas Police Department's priority agenda of which four of the six issues resulted in the passage of legislation.

The committee had the following concerns/recommendations: (1) law enforcement standard and education (2) funding for training (3) educational segment of training (4) metal theft (5) effective date of enforcement and (6) video conferencing.
