### History of Graffiti Abatement in Dallas


Various City Departments abate graffiti

- Parks Department Park property
- Street Department Street Signs, bridges
- Code Compliance private property
- Brush Buster Program moved from Sanitation to Code Compliance via mutual agreement on February 1, 2006
  - Transferred 1 FTE position to Code Compliance along with small budget for paint/supplies

#### Quarterly Calls to 311 Call Center (Public and Private)




### Yearly Calls to 311 Call Center (Public and Private)

- •Increase of 30.4% from 2004 to 2005
- •Increase of 46.0% from 2005 to 2006 (using Q1/Q2 data)
- •72% of calls are related to private property
  - 69.2% Residence/business
  - 2.8% Apartments

### History of Graffiti Abatement in Dallas



Three Areas of Concentration

- Southwest North Oak Cliff
- Downtown North and Northeast of Downtown
- East/Northeast

Also along major roadways such as I-35, I-75, northern LBJ

# FY05/06 Accomplishments

### Volunteer Efforts – 282 sites abated

- Swiss Avenue October 2005
- Old East Dallas March 2006
- Citywide Paint Out May 2006
- Mow Clean 589 sites abated

### Total sites abated to date: 871



- Paint has been donated by Sherwin Williams and The Meadows Foundation
- Atmos Energy donated one Ford F-150 pickup truck for Mow Clean crews to abate graffiti
- Leadership Dallas donated one Ford F-250 pickup truck for Mow Clean crews to abate graffiti

### **FY05/06 - \$75,969**

Includes 1 FTE position – Graffiti Coordinator

### Proposed for FY06/07 - \$196,721

Includes: 4 FTE - 1 Graffiti Coordinator, 1 Abatement Supervisor, 2 laborers Paint matching equipment Funds for street sign replacement

# Future Goals

### Enhance Graffiti Program

- Add to existing staff: 1 abatement supervisor and 2 laborers with goal to remove graffiti within 48 hours
- Acquire paint matching equipment for more aesthetic abatement, eliminating "patch work" effect
- Expand database of signed consent forms to facilitate legal ability to quickly abate graffiti
- Facilitate coordination with DPD Gang Unit and other city departments
  - Share information on sites, trends
  - Share resources, if needed
  - Review program for best practices

# Future Goals

### Develop and expand public outreach

- Call 311 to report
  - All graffiti/tagging is illegal (i.e. Class of '06, Suzie ♥ Jonnie, etc.)
  - Don't have to accept as part of the neighborhood
  - Tips on how to deter graffiti
- August 19, 2006 Mayor's Summer Reading Program Finale
- September 19, 2006 meeting with Northwest Dallas Improvement League
- September 23, 2006 Trinity River Trash Bash at Samuell Grand Park
- October 4, 2006 graffiti activity/presentation at Audelia Road Branch Library

# Future Goals

Create database of community volunteers

- Utilize HOAs, neighborhood assoc, scout troops, faith-based groups, schools
- Expand database of signed waivers
- Concentrate abatement in hard hit areas of the City, then moving outward to all areas
  - October 14, 2006 paint-out planned in Lower Greenville area
- Utilize staff to accomplish goal of locating and abating graffiti within 48 hours
