5. Family Violence Unit

The purpose of this presentation is to provide an update on Family Violence Unit program improvements in:

The goals of the Family Violence Unit program are as follows:

- Reduce overall crime rate by:
 - Improving Lethality Assessment Program
 - Training for all Officers for more efficient call response
- Increase participation with the community by:
 - Promoting Public Education
 - Continuing partnerships with advocates and shelters

Family Violence Facts:

- One in every four women will experience domestic violence in her lifetime
- An estimated 1.3 million women are victims of assault by an intimate partner each year
- 85% of domestic violence victims are women
- Most cases of domestic violence are never reported to the police
