#### **Original Plan**


- Funding for the IH-20 Gateway Park was included in the 1998 Bond Program for \$1.3 million
- Location is at the intersection of IH-20 and Dowdy Ferry
- Existing features include an access gate and a small lake





#### **Original Plan**

- Proposed park features include designs for a paved road, fishing pier, pavilion, trail around lake, parking areas and restrooms
- Features to be constructed are dependant on bids received vs. available funding





#### "Early Start" Projects

- Local citizens expressed a desire for a parking lot specifically for horse trailers, and for a median cut on Dowdy Ferry to allow for trailer traffic to enter park
- Citizens also complained about odors emanating from vent stacks on a DWU wastewater line, and illegal dumping on site
- Work was completed using City Staff (Streets, DWU) & contractors
  - Gravel road and parking lot (100 ft. x 300 ft.)
  - Odor filters for vent stacks
  - Bollards along Rylie Rd. to prevent illegal dumping
- Median cut to be completed by contractor services

#### **Funding Overview**


- 1998 Bond Program Funds \$1.3 million
- Funding spent to date \$421,803
  - Master Planning & Design \$221,671
  - Parking lot & Gravel Road \$170,000
  - Bollards along Rylie Rd. \$30,192
- Remaining funds \$878,197
  - Median cut (estimate) \$75,000
  - Park amenities \$803,197



#### **Schedule**

- The permanent parking areas and entry roadway must be resurveyed and redesigned (to avoid a sanitary sewer line on the site)
- Resulting schedule is as follows:
  - Begin survey work in December 2010
  - Complete plans and bid project in April 2011
  - Award construction contract in June 2011
  - End construction in December 2011





    - Held at Rochester Park, it is a timed trial where participants use a compass and map to navigate forest trails to find specific map markers
    - It teaches map reading skills, recognition of land features, and outdoor team building





- 7<sup>th</sup> Annual Trinity River Levee Run
  - Event Date: March 5, 2011
    - City of Dallas, Trinity Commons Foundation and Dallas Running Club produce this event
    - 500 1000 runners
    - This year will feature, new certified race course using more roads; runners will again cross Continental Avenue Bridge
    - Glenn Carter Safety Challenge between the COD Fire and Police department cadets
    - Kayak Paddle Adventure on Crow Lake with free kayak lessons and access to paddle a kayak
    - Tailgate Party





- Standing Wave Grand Opening
  - Milestone Event Date: February/March 2011
    - Major Trinity River celebration for the City with the public and media invited to mark achievement
    - The opening will also be used to announce the Texas Paddling Trails certification
    - Festivities will include a formal opening ceremony with the Dallas City Council
    - Kayak trick and fun paddle exhibition

#### Trinity River Wind Festival

SUBJECT Periodic Inspection Report No. 9 Maintenance Deficiency Correction Period (MDCP) November 2010 Update

As of November 30, 2010, the City has completed 185 of the 198 items in the MDCP plan which is the action plan staff submitted to the US Corps of Engineers (Corps) to address the O&M deficiencies in the levee system as described in the Periodic Inspection Report No. 9 (PI #9).

The remaining 13 MDCP items to be completed are grouped as follows:

- o 6 items related to tree removal these items will be addressed upon completion of the current tree removal contract
- 1 item related to a plan to systematically inspect pipes, culverts or conduits in the levees the plan has been submitted to the Corps and will be removed from this list upon Corps' approval of the plan
- 1 item related to encroachment in the flood plain due to construction equipment for the Margaret Hunt Hill Bridge - this item will be addressed upon completion of the bridge construction
- o 2 items related to locating or obtaining permits for multiple utility crossings at the Central Wastewater Treatment Plant Levee – the plans have been submitted to the Corps and will be removed from this list upon Corps' approval of the plans
- 3 items related to erosion two of the work will commence at the completion of the Standing Wave project and one will commence towards the completion of the Margaret Hunt Hill Bridge

The City is anticipating the Corps' written approval on the MDCP items field inspected on October 29, 2010.





### **BACKGROUND**

This item authorizes the abandonment of a portion of an alley to the City of Dallas, the abutting owner. The area will be sold to Oncor Electric Delivery, for the transition facility associated with the Oncor Electric Delivery – West Levee Norwood (Electric) Transmission Line. The cost for this abandonment is the minimum processing fee pursuant to the Dallas City Code, therefore, no appraisal is required. The abandonment fee is based on Dallas Central Appraisal District values.

Notices were sent to 34 property owners located within 300 feet of the proposed abandonment area. There were no responses received in opposition to this request.

This transaction is consistent with the recommendations of the Real Estate Task Force.


