Narrative	The occupant of this apartment, in an attempt to hasten the burning of BBQ charcoal in a grill, poured gasoline from a water bottle onto the charcoal, located outside of the front door on the second floor walkway. The fire flashed and ignited the gasoline in the bottle. When the occupant moved away from the flash, burning gasoline splashed on him causing thermal burns. The burning gasoline also splashed on a juvenile male, standing next to the occupant, causing the right arm of his sweater to ignite leading to thermal burns to the tips of the juvenile's right hand. The occupant then threw the flaming bottle down the stairway where it landed on two female juveniles, on the first floor landing, causing thermal burns to the juveniles. There was no structural or content loss. Insurance information is unknown. Engine 22 was the first apparatus to arrive on-scene.
